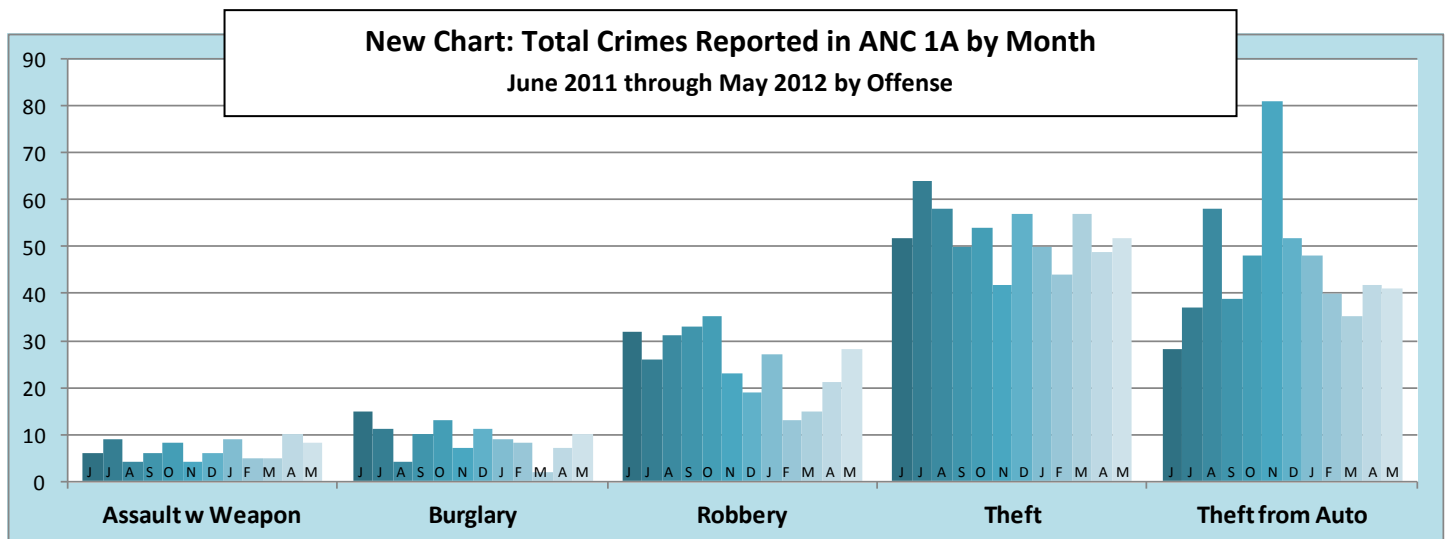

## What's the difference between burglary, robbery, and theft?

One could say that the general term for all three crimes is theft, but burglary and robbery involve particular circumstances.

**Burglary** involves someone entering a building or home without permission ("breaking in") to commit the crime of theft. **Robbery** is theft from a person, often combined with violence or threat of violence.

**Theft** is taking someone else's property, without breaking in, and without taking it from the person directly.

## DC Fish Carryout: MPD Bust, Felony Arrests for Crack – Community Petitions to Revoke Liquor License



Based on strong investigative leads that crack cocaine was being sold on the premises, DC's Metropolitan Police Department executed a search warrant at the DC Fish Carryout, 3475 14th Street NW, in February 2012. Three defendants were arrested for felony distribution of crack cocaine. Those arrested included the DC Fish Carryout's owner, Suk "Bruce" In Hyun, 54, who holds a DC license to sell tobacco and alcoholic beverages.

So far, over 400 community members signed a petition and/or wrote letters to support ABC license revocation. The ABC Board is holding hearings to decide the matter.
