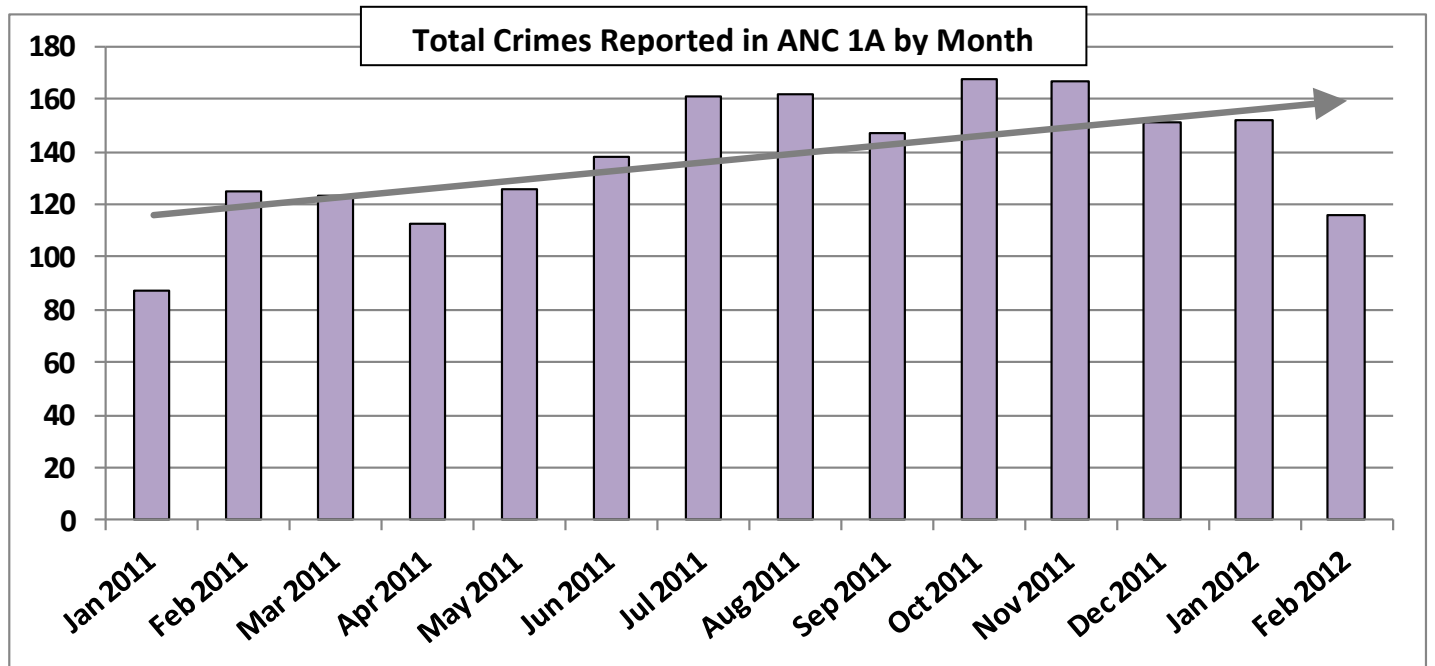

Column Heading	Description
Sentencing Date/ Sentenced	Date the defendant will be (or was) sentenced by the judge. For best results, submit Community Impact Statements at least ten business days prior to the sentencing date.
DCSC Case No.	DC Superior Court case number. Find case information online at https://www.dccourts.gov/cco/maincase.isf
Defendant's Name	Name of the defendant who has pleaded guilty/was found guilty of the charge.
Charge	Charge #1 for which the defendant is being sentenced. There may be additional charges.
Location of Offense	Approximate address where the offense occurred.
Approx No. of Cases	How many DC Superior Court criminal cases the defendant has had. Note: The number may not be exact.
Results	The amount of jail time the defendant was sentenced to serve. Notation: X/Y: "Y" is the sentence, and "X" is the portion that was not suspended—how much time the defendant will actually serve.
