Criminal Justice Accountability Initiative:

Many are not aware of the problem of chronic repeat criminal offenders in our community. The same defendants commit crime after crime, are arrested, sentenced and then released, only to commit more crimes. Our criminal justice system has become a "revolving door" for many chronic criminals. It's up to us to help "close the revolving door."

There are ways that ordinary people with busy lives and full-time jobs can become more involved. The Community Criminal Justice Accountability Initiative (CCJAI) is a program that began in Columbia Heights in April of 2009 to address public safety concerns and chronic repeat offenses. CCJAI, a partnership of law enforcement, criminal justice agencies and community members, has submitted 70 Community Impact Statements to judges at sentencing, and has tracked over 500 criminal cases. Our stakeholders include MPD, USAO, OAG, PSA, CSOSA, the DC Council, DC Superior Courts, the ANCs, and community members. Together we are working to make our criminal justice system better, while reducing the burden of chronic repeat offenses. You can help by writing community impact statements in criminal cases in your neighborhood. Protecting the next victim is everyone's responsibility!

What Can You Do Right Now to Prevent Crime?

- Above all, don't make yourself an easy target for crimes. Take precautions and act responsibly.
 - Lock your home and safeguard your belongings. Take extra precautions against burglary when you go out of town.
 - When you leave your car, lock it and take your keys. Never leave valuables in your car in plain view.
 - Avoid walking alone, especially late at night
- Report every crime to the police. Don't take "no" for an answer. Go to the police station if you have to. If you are the victim of a crime or a witness, cooperate fully with the police and prosecutors.
- Become a Neighborhood Watch Block Captain. Get to know all your neighbors. Do community service. Get to know your public officials and community stakeholders.
- Become familiar with repeat offenders in your neighborhood and their conditions of release. Report violations to the police. Write community impact statements to let judges know how crime in your neighborhood affects you and your family. Visit the courts to observe trial proceedings. Do your Jury Duty service.
- Become more involved in public safety issues in your community. Go to PSA meetings and get acquainted with people in the MPD in your area. Track crime rates in your area to help stop new trends. Join MPD's Email Discussion Groups for Crime Prevention Tips: <http://mpdc.dc.gov/mpdc>
