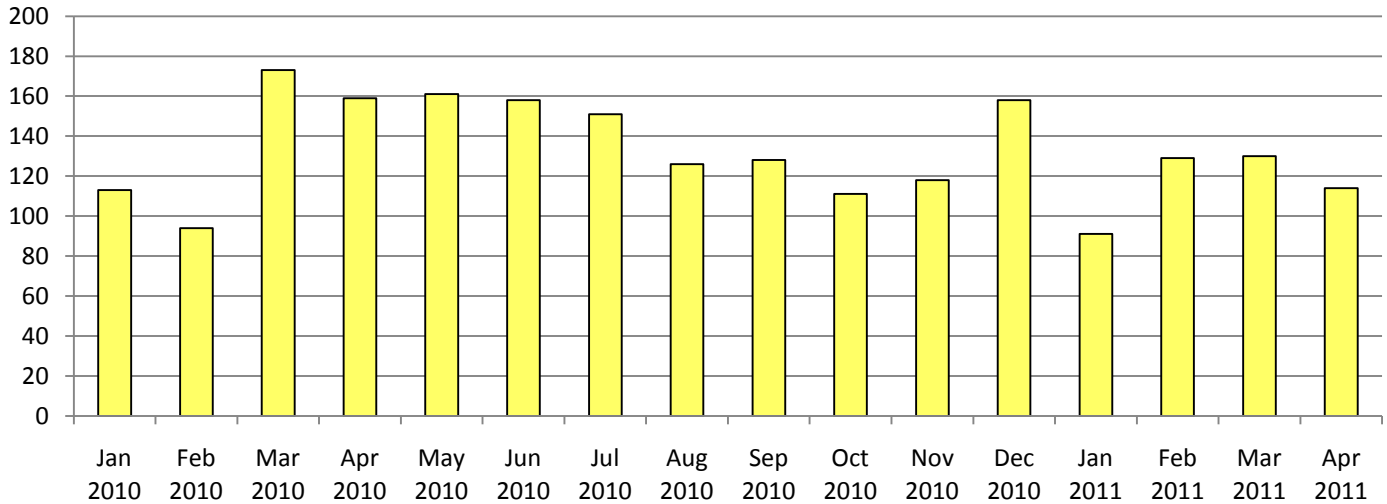

The same defendants commit crime after crime, are arrested, sentenced and then released, only to commit more crimes. It's up to us to help "close the revolving door" and see that our system hands down meaningful sentencing, along with appropriate rehabilitation.

You can help by writing Community Impact Statements for criminal cases in your neighborhood. Here's the current list of cases tracked by CCJAI that are now **pending sentencing**, for ANC IA and beyond.

All of the defendants shown in the following table have either pled guilty or have been found guilty. The defendants will be sentenced by the courts on the Sentencing Date:

Key to Case Information Shown in the Table:

Column Heading	Description
Sentencing Date	Date the defendant will be sentenced by the judge. Community Impacts must be submitted at least one week prior to the sentencing date. Two weeks prior is the standard. Note: There is only lead-time for some of the cases shown.
Defendant Name	Name of the defendant who has pled guilty/was found guilty of the charge.
Age	The defendant's age.
No of Cases	The number of defendant's papered arrests shown in the DC Superior Court's Online system.
Charge	Charge #1 for which the defendant is being sentenced (Note there may be additional charges).
Location of Offense	Address where the offense occurred
ANC SMD	The ANC Single Member District where the Location of Offense is.
ANC	Commissioner of the SMD of the Location of Offense.
Release Conditions	Whether or not the defendant is being held in jail. PR-HISP is "High Intensity Supervision Program." Most defendants are not held in jail while their cases are resolved, but they are required to follow conditions.

Notes on Cases:

- Cases in **bold** have been identified as high-priority
- There is time to submit community impact statements for cases that are coming
- **Unauthorized Use of a Vehicle** (as in Line 2). Often, when defendants are charged with UUV, it is strongly suspected that they actually stole the car they were caught driving without the owner's permission, but it can't be proved that they actually stole it, only that they were driving it.
- Sexual Solicitation: A chronic repeat offense that accompanies the culture of crack cocaine in our communities, eroding quality-of-life. Also a public health concern.
- As you can see, many of the defendants have many prior arrests. Some do not, but are still considered high-priority. Although they don't have many prior cases listed, Numbers 17 and 18 are MS-13 gang members and well-known criminals.
