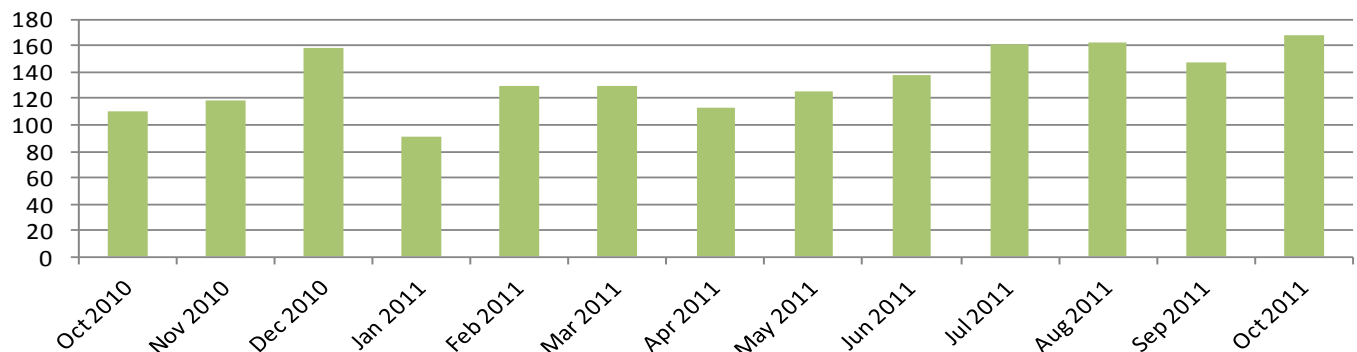

What can YOU do? You can help by writing Community Impact Statements for cases now **pending sentencing**. All of the defendants shown in the following table have either pled guilty or have been found guilty. All the listed charges are felonies.

| Defendant's Name | Name of the defendant who has pled guilty/was found guilty of the charge. |
| Charge | Charge #1 for which the defendant is being sentenced. There may be additional charges. |
| Location of Offense | Approximate address where the offense occurred. |
| Results | The amount of jail time the defendant was sentenced to serve. Notation: X/Y: "Y" is the sentence, and "X" is the portion that was not suspended—how much time the defendant will actually serve. |
