A RESOLUTION SUPPORTING A MURAL AT 3124 GEORGIA AVE NW WDC

WHEREAS; Lower Georgia Avenue has its share of vacant and abandoned properties, which has attracted criminal activity, including vandalism and graffiti tags;

WHEREAS; Words, Beats and Life, Inc has agreed to partner with local artists and community members to replace illegal graffiti with artistic works, which promotes beautification, vibrancy and economic vitality to commercial corridors and engages community members in the process of creating and appreciating the benefits of public art;

WHEREAS; Words, Beats and Life would provide supplies, instruction in proper technique, and facilitate the necessary approvals needed to legally practice and perform public art on private spaces;

WHEREAS; Words, Beats and Life will facilitate the process for identifying a site, seeking community involvement, selecting artists, choosing design options, soliciting volunteers and managing project timelines and project duties;

WHEREAS; Words, Beats and Life will work closely with ANC1A and members of the community, and in coordination with Georgia Avenue Thrive, throughout this process;

WHEREAS; The selected site for the Words, Beats and Life mural project is located at 3124 Georgia Ave NW WDC 20010;

WHEREAS: The owner of 3124 Georgia Ave NW WDC 20010, Solomon Askariama, has met with Words, Beats and Life, ANC1A10 Commissioner Rashida Brown and members of the community representing Georgia Avenue Thrive to gain the necessary approval.

BE IT RESOLVED THAT: Advisory Neighborhood Commission 1A supports this mural project located at 3124 Georgia Ave NW and will engage the Commission and share documentation as approved by the owner.


Certification:


